Fubo Sportsbook Iowa House Rules. V.1.4

1 General Rules

- 1.1 Fubo Gaming Inc. (also referenced as Fubo Sportsbook) reserves the right to modify the House Rules at any time, subject to regulatory approval.
- 1.2 Fubo Sportsbook reserves the right to accept, limit, or refuse any wager.
 - 1.2.1 The types of wagers accepted by Fubo Sportsbook are:
 - Point Spread/Spread – Teams are favored by a certain number of points, goals, runs or games. The spread number can be a whole number (e.g., 7) or a half number (e.g., 7.5). Wagers can be placed on either side of the spread (favorite or underdog);
 - Moneyline – Outright winner of a game;
 - Parlay – Two or more selections combined in one wager. All selections in a parlay must win for a payout unless one or more selections are determined to be a push or void. Push results or void games will be ignored for settling purposes. Odds for remaining selection(s) will be multiplied to determine payout;
 - Teaser – Teasers allow the player to adjust the points spread in exchange for reduced odds. E.g., If Team A is 10.5 favorite over the Team B the player can select the Team A -4.5 in a six-point teaser. Rules and payouts for Teasers are covered in section 19;
 - Futures – A wager that will be determined on an event to be held at a later date (e.g., Superbowl);
 - Round Robin – A set of smaller parlays based on a greater total number of selections. E.g., selecting a two game parlays from three selections = 3 wagers; two game parlays from 4 selections = 6 wagers; selection three game parlays from 4 selections = 3 wagers etc. All selections in each parlay must win for a payout unless one or more selections are determined to be a push or void. Push results or void games will be ignored for settling purposes. Odds for remaining selection(s) will be multiplied to determine payout;
 - Proposition – A wager that relates to the occurrence or non-occurrence during a game that is not tied to the final score or outcome of a game (e.g., First touchdown scorer or over/under total passing yards in NFL);
 - In-Game Straight – Wagers placed after a game or event have stated;
 - Pre-Game Straight – Outright winner of an event or a game such as two-way Moneyline, winners of a soccer match (e.g., Team A to beat Team B) or tennis game (e.g., Player A to beat Player B); and
 - Totals (Over/Under) – A wager on the final score to be over or under a total number of points or goals.

1.3 Fubo Sportsbook reserves the right to void any wager where an obvious error is made on the market price of a wager.

1.3.1 An obvious error is defined as a misstated line or misstated odds of a wager or where the terms offered on a wager are materially different from those available to the general market at the time the wager is placed due to technical problems or human error. By way of definition, “clearly” or “materially” out of line / different odds are considered to be those that would leave Fubo Sportsbook’s odds in a position to be arbitrated against the market consensus. E.g., a moneyline market where Team A is generally offered between -190 and -210 by market consensus. Whilst their opponent, Team B, is generally offered between +155 and +175. If, in error, Team A is offered at -110 then a player can wager each team at -110 and +175 respectively and guarantee themselves a profit. In this case the odds of -110 offered on Team A would be deemed clearly or materially erroneous. An obvious error also includes incorrect start or end times of events being entered into the sports bet system which allow wagers to be made after an event has physically started. This applies to individual wagers as well as wagers that are part of a multi-event, such as a parlay.

A non-exhaustive list of obvious errors include:

- Odds/Lines that are materially different from the general market at the time of placement or clearly wrong given the probability of the event;
- Transposed odds/lines;
- The rules and terms of the actual event are materially different to those described (e.g., incorrect number of rounds or sets);
- Wagers placed during malfunction of data or odds/live feeds;
- Pre-Event wagers placed after the actual start time of the event;
- Wagers placed after the outcome of the wager is known;
- Wagers placed on events where the home team or player has been transposed except in events and tournaments with an officially set schedule such as a Tennis ATP event or a Soccer World Cup;
- Wagers that have been manually settled using the incorrect odds/lines or calculation.

1.3.2 Wagers placed on duplicate outcomes on same event as part of a Parlay, Teaser or Round Robin will be treated as a wager on a single outcome unless otherwise indicated. If the odds/line is different, the wager will be settled using the odds/line most favorable to the player at the time of placement. If the outcome was already established at the time of placement, the wager will be voided.

- 1.3.3 Records will be kept by Fubo Sportsbook of all point spreads, final scores, odds, and any other related wagering statistics for reference in case of any technical, mechanical, or human error.
 - 1.3.4 If Fubo Sportsbook is forced to make a change (e.g., odds or proposition) to any previously made wager by a patron, Fubo Sportsbook will immediately notify the patron by email using the contact information on the patron account.
 - 1.3.5 Parlay bets where the results of two or more outcomes are related are not accepted unless otherwise indicated (E.g., Same Game Parlays). In the event such a wager is taken in error the selection with the largest odds will count towards the payout while any other related outcome(s) will be voided. If the odds for the related bets are the same, Fubo Sportsbook will split the stakes equally between the related outcomes. If the related events are settled at different times, the wager will be settled on the second leg of the event (e.g., LA Dodgers to win National Division West and the World Series double will be settled using the odds for the World Series only).
- 1.4 Odds Boosts/Specials
- 1.4.1 All legs of the Odds Boost/Specials will be settled by the rules of the respective sport or prop.
 - 1.4.2 If any leg of the Odds Boost/Specials is postponed, cancelled, or incomplete per respective rules, the entire wager will be voided and refunded regardless of the results of the other legs.
- 1.5 Fubo Sportsbook reserves the right to correct any error made in the case of incorrect settlements and re-settle the bet correctly.
- 1.6 Fubo Sportsbook acknowledges that some bets might require the rounding of percentages, units or other criteria which are decisive for the settlement of the bet. Should that be the case, Fubo Sportsbook reserves the right to adjust and settle accordingly. (E.g., \$1000 staked at -110 returns \$1909.091 which is rounded down to the nearest cent; \$1909.09)
- 1.7 Iowa law prohibits persons under the age of 21 from participating in sports wagering or collecting winning wagers. By opening a wagering account, patrons acknowledge being at least 21 years of age and that they are prohibited from allowing access to their account by another person. There will be no bets accepted from outside the State of Iowa.
- 1.8 A Prohibited Participant includes any individual whose participation may undermine the integrity of the betting or the sports event, or any person who is prohibited for good cause.

A non-exhaustive list of Prohibited Participants includes:

- Any person on the Iowa Racing and Gaming Commission (IRGC) list of persons barred from event wagering platforms
 - Any individual whose participation may undermine the integrity of the wagering, the sports event or the other event.
 - Any individual who is prohibited from placing a wager as an agent, proxy or because of self-exclusion.
 - Any individual who is an athlete, coach, referee, player, trainer or personnel of a sports organization in any sports event or other event overseen by that individual's sports organization who, based on information that is not publicly available, has the ability to determine or to unlawfully influence the outcome of a wager.
 - An individual who holds a position of authority or influence sufficient to exert influence over the participants in a sporting contest, including coaches, managers, handlers and athletic trainers, such that their actions can affect the outcome of a wager.
 - An individual with access to exclusive information on any sports event or other event overseen by that individual's sport's governing body that is not publicly available information or any individual identified by any lists provided by the sport's governing body to the IRGC.
- 1.8.1 If you are a Prohibited Participant, you may not make wagers with the Sportsbook.
- 1.8.2 If you are found to be a Prohibited Participant your account will be closed and all funds which have been cleared will be refunded to you. No additional wagering activity will be allowed.
- 1.8.3 By opening a wagering account, the patron accepts and acknowledges they are not a Prohibited Participant.
- 1.8.4 A person on any excluded list whether the individual is excluded voluntarily or involuntarily, may not have an account or wager with Fubo Sportsbook.
- 1.8.5 Employees of Fubo Sportsbook and any employees of Fubo TV or its affiliates who are involved in, responsible for, or licensed or found suitable in connection with the sports betting activities of Fubo Sportsbook are strictly prohibited from establishing wagering accounts or placing bets through Fubo Sportsbook online sports betting system.
- 1.9 By opening a wagering account, the patron acknowledges reading, understanding, and accepting Fubo Sportsbook's Terms and Conditions.
- 1.9.1 It is prohibited for any person to use or be allowed to use someone else's wagering account
- 1.9.2 It is prohibited to place a wager on behalf of another person.

- 1.10 By placing a wager, the patron acknowledges reading, understanding, and accepting Fubo Sportsbook's House Rules.
- 1.11 Patrons may only fund their sports wagering account through deposits, promotional credits, and winnings from wagers. Fubo Sportsbook does not issue patrons lines of credit to make wagers. Additional rules regarding deposits and withdrawals are set forth below.
- 1.12 Wagers are settled on the official result published after the event has finished.
 - 1.12.1 Winnings from settled wagers will be added to the patron account.
 - 1.12.2 Fubo Sportsbook reserves the right to withhold payments from wagers if the patron account or the event has been flagged as unusual or suspicious.
- 1.13 Future or outright wagers are considered action if a winner is officially announced, regardless of team relocation, team name change, league affiliation, playoff format, or season length, unless otherwise specified below, within rules particular to a specific sport.
 - 1.13.1 Where an incomplete list of participants/teams is displayed (e.g., Tennis US Open), the patron may request Fubo Sportsbook to add and price a new participant/team that is expected to take part in the event.
- 1.14 All prices and odds are subject to change. Posted odds will be updated automatically on every market listed on Fubo Sportsbook's Sportsbook.
- 1.15 It is the responsibility of the patron to confirm wagering selection accuracy before submitting a wager. Once the wager is accepted it cannot be voided or altered except at the discretion of Fubo Sportsbook or at the direction of the Iowa Racing and Gaming Commission (IRGC).
- 1.16 Wagering options, except in-play/live markets, are available up until the official start of the event.
- 1.17 The start time of an event is deemed official if rescheduled/delayed due to weather, late arrivals of participants/teams, power outage or any other reason as long as the game starts within the time specified in the individual sports rules.
- 1.18 Straight bets that are settled as a push or deemed no action will be refunded, unless the selection is part of a parlay or teaser bet, in which case parlay and teaser rules will apply.
- 1.19 Dead Heat rules will be used when applicable to ties and the wager will be adjusted accordingly. The payout will be calculated after the odds are divided by the number of winners and then multiplied by the stake.

- 1.20 If a change in venue occurs from the originally scheduled venue, there will be no action and wagers will be refunded unless otherwise specified within rules particular to a specific sport.
- 1.21 Wagers on the performance of an individual player in a team event will be considered void if the player does not compete in the event.
- 1.22 The minimum wager at Fubo Sportsbook is \$1.00.
- 1.23 The maximum wager amounts will be determined by Fubo Sportsbook, including on a case-by-case basis. Such limits will only be applied through limiting the amount wagered prior to acceptance and will not be applied to reduce a winning wager amount. The maximum payout is \$1,000,000.00. All accepted wagers will be paid at full odds.
 - 1.23.1 Max limits by sport/event are listed in [section 20](#).
 - 1.23.2 If a group of patrons are suspected of colluding to circumvent wagering limits or max pay-out limits, Fubo Sportsbook reserves the right to restrict pay-out to a single payout based on max pay-out limit for that event as it was set in the system at the time of placement.
 - 1.23.3 The max pay-out for a parlay will be determined by the limits of the selection/outcome with lowest max pay-out.
- 1.24 A parlay bet will be reduced to the next number of teams played if any of the games result in a betting tie (push), selection(s) become no action, void, or if any of the games are postponed.
- 1.25 Teaser bets are governed by the same rules as parlay bets. The one exception is in the case of two team teasers. If one of the games results in a betting tie (push), there is no action regardless of the result of the other selection.
- 1.26 Calculations for wager types:
 - 1.26.1 **Point Spread Payout** - This consists of two elements:

The first element is the point spread, where points are either notionally deducted from or added to a team's score to attempt to balance the competitiveness of the game.

The perceived stronger team (the favorite) has the points spread value notionally deducted from their score, whereas the perceived weaker team (the underdog) has the points spread notionally added to their score.

If, at the conclusion of the relevant period of play, the score difference between the two teams is less than the points spread, then the team receiving point(s) (+) will be the winner. If the score difference is greater than the points spread, then the team giving point(s) (-) will be the winner. If the score difference is equal to the points spread, then neither team will win, and the result is deemed to be a 'push' and the wager amount is refunded to the patron. This is illustrated in the example below:

Team A @ Team B

Team	Point Spread	Odds
Team A	+3	-110
Team B	- 3	-110

Score Scenarios:	Actual Score	Score Difference	
Team A	19	2	Team A wins with their + 3 points spread

The second element is the odds associated with each team which are used to calculate winnings in the same manner as described for the Moneyline Payout described below.

Please note, that in many games the points spread will include a half point (.5). This has the effect of removing the possibility of a 'push' as the score difference can never be equal to the absolute points spread, so a winner can always be determined.

- 1.26.2 **Moneyline Payout** - The Moneyline odds, in US format, will be expressed as either a positive (+) or a negative (-) number. If the odds value is **negative** this denotes the wager amount required to win \$100 (e.g., a wager of \$110 at -110 would win \$100, with a total return of \$210). If the odds value is positive this denotes the value of the winnings a patron would receive for a wager of \$100 (e.g., a wager of \$100 at +200 would win \$200, with a total return of \$300).
- 1.26.3 **Parlay Payout** - Odds will be calculated based on the prices of the individual selections.
- 1.26.4 **Teaser Payout** - Odds are taken from a fixed payout chart.
- 1.27 Winning wagers may be subject to IRS reporting and withholding guidelines.
- 1.28 Wagers are subject to Anti-Money Laundering (AML) standards including internal and external investigation and reporting requirements. Furthermore, the structuring of bets to avoid such requirement is strictly prohibited.
- 1.29 Fubo Sportsbook does not recognize protests, vacated wins, or overturned decisions for wagering or re-settlement purposes.
- 1.30 Any rules written for specific events, such as special prop bets or in-play markets, are considered House Rules.
- 1.31 Data and statistics are provided to Fubo Sportsbook from a third party. Fubo Sportsbook as well as any vendors of Fubo Sportsbook assume no responsibility for inaccuracies or delay in data offered on the Fubo Sportsbook website or app.

- 1.33 If you are not satisfied with how a bet or market has been settled, please provide details of your dispute to Fubo Sportsbook Support.
 - 1.33.1 Any complaints, claims, or disputes involving the services or any other activity should be brought to the attention of Fubo Sportsbook Support by following the procedures described under the “Concerns or Complaints” section of the Patron Protection page, available [here](#).
 - 1.33.2 Every patron complaint will be investigated by Fubo Sportsbook, with a response provided to the patron within five calendar days.
 - 1.33.3 In the event of a dispute or complaint, that you are unable to resolve through the internal Fubo Sportsbook Support dispute process without a satisfactory outcome, and the betting dispute is related to betting that took place in Iowa you may contact the IRGC. 1.34 For wagering purposes, event results are official after:

- **Football** (NFL, CFL, and NCAA)-55 minutes of play
- **Basketball** (NBA)-43 minutes of play
- **Basketball** (NCAA)-35 minutes of play
- **Basketball** (WNBA & FIBA rules)- 35 minutes of play.
- **Hockey** (NHL)-55 minutes of play.
- **Soccer**-90 minutes of play plus stoppage time excluding overtime and/or penalty shootouts unless otherwise indicated.
- **Boxing/MMA** (Professional and Amateur)- When the bell (or any other device used to sound and signify the start of a round) is sounded to start the opening round, the match is considered official for betting purposes.
- **Baseball** (Major League, Minor League, College)-Called games must complete 5 innings or 4 ½ innings if the home team is ahead.
- All other sports will be official at the end of the scheduled length of play or scheduled time limit unless otherwise specified within rules particular to a specific sport.

1.35 When wagering on full game or second half events, overtime will be included unless otherwise stated above or addressed in the specific sports section.

1.36 Overtime will not apply to any wager on the fourth quarter.

1.37 All games must be played on the date specified. If a game is postponed and/or rescheduled, wagers will be considered no action unless otherwise specified.

1.37.1 Teams must play all scheduled games in their respective regular season in order for all over/under season wins/points wagers to be considered action, unless otherwise specified within the rules particular to a specific sport.

1.38 Full season prop bets include regular season only unless otherwise specified.

1.39 Player stats will stand regardless of any trades during the season.

1.40 Wagering is not permitted on any Prohibited Wagers. A Prohibited Wager includes:

1.40.1 Proposition wagers involving individual athletes who compete on behalf of any Iowa collegiate team, even if the competition takes place outside of Iowa.

- 1.40.2 Wagers on the performance of athletes in individual international sporting events governed by the International Olympic Committee if any participant is under 18 years of age.
- 1.41 When the 'Accept all line and/or odds changes' feature is enabled, any line or odds changes between making the selection and confirming the wager will automatically be accepted regardless of whether the line/odds move is in the favor of the player or not.
 - 1.41.1 When the 'Accept all line and/or odds changes' is disabled only changes favorable to the patron is automatically accepted by the system when the player is confirming the wager.
- 1.42 Calculations of wagers:
 - 1.42.1 The odds are expressed as a (minimum) 3-digit number with a minus indicating the stake needed for a \$100 win (e.g., -150 = \$150 stake to win a \$100). The stake is added to the to the win if it is a winning wager (Pay-out = \$250 in the above example).
 - 1.42.2 The odds are expressed as a (minimum) 3-digit number with a plus indicating the win for every \$100 stakes (e.g., +250 = \$100 stake to win a \$250). The stake is added to the to the win if it is a winning wager (Pay-out = \$350 in the above example).
 - 1.42.3 For Parlays the odds of each outcome/selection is multiplied to determine the win/payout (+110 x +120 with a \$100 wager = \$462 pay-out). If any outcome/selection is void it will be ignored for settling purposed but remaining outcomes/selections will be multiplied to determine pay-out.
 - 1.42.4 Odds for Football and Basketball teasers can be found in the payout chart listed in section 19.
- 1.43 Fubo Sportsbook will endeavor to ensure all data and scoreboards provided on site are accurate. However, due to time delays or possible feed issues this information is intended to be used as a guide and Fubo Sportsbook cannot assume any liability for the accuracy of such data.
- 1.44 Please note in-play events and markets will sometimes be suspended for trading reasons. This can be caused by events such as on-field activity, replay reviews or uncompetitive events/markets.
- 1.45 Except where specifically provided for in the Specific Sports Rules, the General Rules apply to all wagers made on the below products. In the event of a conflict between the Specific Sports Rules and the General Rules, the Specific Sports Rules will govern. For any category of wagers or markets not mentioned in the Specific Sports Rules, the General Rules shall apply.

2 Football

- 2.1 Overtime periods counts for all markets unless otherwise indicated.
 - 2.1.1 When wagering on game totals (over/under) and 2nd half wagers, overtime periods are counted in the final score unless stated.
 - 2.1.2 Fourth quarter markets do not include overtime.
- 2.2 For the highest scoring quarter, overtime scores DO NOT count towards 4th quarter scoring.
- 2.3 Future wagers are considered action as long as a winner is officially declared, regardless of event/team relocation, rained out events, season length, etc., unless otherwise specified.
 - 2.3.1 If applicable post season/playoff games will be included in future wagers.
- 2.4 All games must be played on the date specified. If a game is postponed and/or rescheduled, wagers will be considered no action, unless otherwise specified on the Fubo Sportsbook wagering platform, wagering sheet, or odds board.
- 2.5 NFL Regular Season Wins wagers and matchups are based on teams completing 17 regular season games unless the remaining games during the season will not affect the result.
- 2.6 Canadian Football League Regular Season Wins wagers and matchups are based on teams completing 18 regular season games unless the remaining games during the season will not affect the result.
- 2.7 NCAA Regular Season Wins wagers and matchups are based on teams completing regular season games unless the remaining games during the season will not affect the result.
- 2.8 College football Regular Season Wins wagers will not include Conference Championship or Bowl games.
- 2.9 In a points or total spread market wagers will be deemed a push if the score lands on the whole number and stakes will be refunded (straight wagers/singles).
- 2.10 Player prop markets on players listed as 'inactive' will be voided. All other wagers will be deemed action.
 - 2.10.1 For seasonal player prop wagers the player must participate in at least one regular season game for wagers to be action.
- 2.11 Parlay wagers on the same game are restricted to Totals and Spread unless otherwise indicated.
- 2.12 In the event that a game is forfeited, due to Covid or any other reason, all wagers are considered no action unless otherwise specified.

3 Basketball

- 3.1 For wagering purposes, a professional basketball game is official after 43 minutes of play.
- 3.2 For wagering purposes, a WNBA game, a college basketball game or a game played under FIBA rules is official after 35 minutes of play.
- 3.3 BIG3 basketball wagers will be settled based on official BIG3 competition rules.
 - 3.3.1 Wagers will be voided and refunded on incomplete BIG3 games, except for markets that have been determined.
- 3.4 All games must be played on the date and at the location specified. If a game is postponed and/or rescheduled, wagers will be considered no action unless otherwise specified.
- 3.5 Full game and second half wagers will include overtime.
- 3.6 Overtime will not apply to any wager on the fourth quarter.
- 3.7 A double-double occurs when a player reaches 10 or more from 2 and a triple-double occurs when a player reaches 10 or more from 3 from the following categories:
 - Points;
 - Rebounds;
 - Assists;
 - Steals;
 - Blocks.
- 3.8 Future or outright wagers are considered action as long as a winner is officially declared, regardless of event/team relocation, postponements, or season length unless otherwise specified.
- 3.9 Over/Under future bets for team wins are based on a 72-game schedule. In the event 72 games are not played, bets will be voided unless the following applies:
 - 3.9.1 The over wager placed cannot be reached by winning all remaining games.
 - 3.9.2 The under wager placed cannot be reached by losing remaining games.
 - 3.9.3 The outcome has been explicitly determined.
- 3.10 Parlay wagers on the same game are restricted to Totals and Spread unless otherwise indicated.
- 3.11 Any market in which the draw or tie is not offered will be declared a push and voided with stakes returned if the market cannot be settled with a winning outcome. This also applies to games played under FIBA rules where odds for a tie/draw is not offered that the game ends in a tie and no overtime is played to determine the money line winner.

Fubo Sportsbook Iowa House Rules. V.1.4

- 3.12 Player prop wagers on players not taking the court will be voided. All other wagers will be deemed action.
 - 3.12.1 11.1 If one or both players in a matchup fails to take court, all wagers will be deemed no action.
 - 3.12.2 11.2 For seasonal player prop wagers the player must participate in at least one regular season game for wagers to be action.
- 3.13 Wagers on NBA Champion, Conference Winners and Divisional Winners will be settled according to the official NBA ruling regardless of any changes to the season length due to labor disputes, Covid restrictions or any other reason.
- 3.14 Non-US Basketball:
 - 13.1 If a match is drawn and no overtime is played to determine a winner all markets that cannot be settled (e.g., Moneyline) will be deemed void. Points Spread, Total Spread, First Quarter markets and other markets that can be settled despite the tie/draw will be deemed action.
- 3.15 NBA Regular Season wins and matchups are based on teams completing regular season games unless the remaining games during the season will not affect the result.
- 3.16 NCAA Regular Season Wins wagers and matchups are based on teams completing regular season games unless the remaining games during the season will not affect the result.
- 3.17 College basketball Regular Season wins and/or Conference wins will not include post season games

4 Baseball/Softball

- 4.1 All bets are Action. A change in Starting Pitcher will have no impact on wagers already made.
- 4.2 For first inning wagers, the first inning must be fully completed for there to be action. There will be action regardless of a change in the originally scheduled starting pitchers.
- 4.3 Total and Run Line wagers:
 - 4.3.1 Baseball - Total and Run Line wagers will be considered action if at least 9 full innings are completed or if 8 ½ innings are completed and the home team is winning.
 - 4.3.1.1 For scheduled MLB 7 inning games Total and Run Line wagers will be considered action if at least 7 full innings are completed or if 6 ½ innings are completed and the home team is winning.

Fubo Sportsbook Iowa House Rules. V.1.4

- 4.3.2 Softball - Total and Run Line wagers will be considered action if at least 7 full innings are completed or if 6 ½ innings are completed and the home team is winning.
- 4.4 Any wager on the First 5 Innings will be decided on the score at the end of 5 full innings.
- 4.5 The result of the game is official after 5 innings or if the home team is winning after 4 ½ innings.
 - 4.5.1 If a game is cancelled or suspended after 5 innings, the winner is determined by the score after the last full inning unless the home team scores to tie or takes the lead in the bottom half of the current inning.
- 4.6 If a game is called or suspended in extra innings, the Total and Run Line wagers will be determined by the completion of the last complete inning unless the home team scores to tie or take the lead in the bottom half of the current inning.
- 4.7 All games must be started on the date specified and completed within 24 hours of the scheduled start time (local time). If a game is postponed and/or rescheduled to start on a different date due to weather delays or any other reason, such wagers will be considered no action.
- 4.8 MLB Regular Season Wins wagers and matchups are based on teams completing regular season games unless the remaining games during the season will not affect the result.
- 4.9 Player prop markets on pitchers not starting the game will be voided.
 - 4.9.1 Batter prop markets on players not starting the game and not having at least one plate appearance will be voided.
- 4.10 For seasonal player prop wagers the player must participate in at least one regular season game for wagers to be action.
- 4.11 Wagers on World Series, League Winners and Divisional Winners will be settled according to the official MLB ruling regardless of any changes to the season length due to labor disputes, Covid restrictions or any other reason.

5 Ice Hockey

- 5.1 For wagering purposes, the game is official after 55 minutes of play.
- 5.2 All games must be played on the date specified. If a game is postponed and/or rescheduled, wagers will be deemed no action, unless otherwise specified.
- 5.3 For specific period bets, the specified period must be played in its entirety for bets to have action.

Fubo Sportsbook Iowa House Rules. V.1.4

- 5.4 Goals in overtime or shootout do not count towards wagers on the third period, first team to score, team totals, and both teams to score unless otherwise stated.
- 5.5 For last team to score wagers, in the event of a shootout, the winning team is considered the last team to score.
- 5.6 In the event of a shootout, the winning team is awarded one goal which is considered in the determination of the winner and loser and counted toward the game total regardless of the number of goals scored in the shootout. This also applies to correct score and odd/even propositions.

- 5.10 NHL Regular Season total points and matchups are based on teams completing regular season games unless the remaining games during the season will not affect the result.

6 Soccer

- 6.1 The entire scheduled period must be completed for a wager to have action unless the market can be settled fully due to a winning selection having already been established.
- 6.2 Wagers are graded after 90 minutes plus stoppage time unless otherwise indicated.
- 6.3 An unplayed or postponed match will be treated as a non-runner for settling purposes unless it is played within 24 hours of the original scheduled start time in which case the bet will stand unless cancelled by mutual consent. If a match is rescheduled from the weekend to a Monday or Friday night for the purpose of live TV coverage, then all bets on that match will stand.
- 6.4 Any match abandoned before the completion of 90 minutes play will be void, unless the match is completed within 24 hours, except for those bets the outcome of which has already been determined at the time of abandonment. The market must be fully determined for bets to stand for example, first player to score or time of the first goal bets will stand provided a goal has been scored at the time of abandonment.
- 6.5 First/Last Player to Score bets are accepted on 90 minutes of play plus stoppage time but does not include any extra time played. Bets on players not taking part in the match will be void.

- 6.6 Result(s) after 10/20/30/40 etc. minutes of play will be settled on the result at the specified time in the match. In the event of match abandonment then all bets will be void unless settlement has already been determined.

- 6.8 Extra time and shootout goals DO NOT count toward the total score of the game.

- 6.11 Corner Kick wagers will not include corner kicks taken in extra time. Corner kicks awarded, but not taken will not count for wagering purposes.
- 6.12 To Advance and To Lift the Trophy wagers on a team to advance to the next level or round of competition will be decided based on the score at the end of the match and will include extra time and penalty shoot outs.
- 6.13 Extra-Time In-Play Markets are settled on the official statistics for the extra-time period. Any goals or corners that were taken or scored during regulation time do not count.
- 6.14 Should there be a dispute over a proposition (e.g., name of the first goal scorer, time of the goal, etc.) wagers will be settled and paid based on reports of the sporting media.
- 6.15 Asian Handicaps are spread bets listed as either with either be 0, 0.25, 0.50, 0.75, 1.0, 1.25 etc. (in increments of 0.25)
 - 6.15.1 +/- 0.25 will mean half the wager stake is on a spread of 0 and half the wager stake is on +/- 0.5.
 - 6.15.2 +/- 0.75 will mean half the wager stake is on a spread of +/- .5 and half the wager stake is on +/- 1.0.
- 6.16 Wagers on Soccer Futures will be settled according to the individual official regulatory body's (E.g., FIFA, UEFA, MLS, Mexican Football Federation) ruling regardless of any changes to the season length due to labor disputes, Covid restrictions or any other reason
- 6.17 Soccer friendlies and tournament games (E.g., Soccer World Cup) may not indicate the actual home team. These games will be listed as advertised by the clubs or the tournament organizer.

7 Tennis

- 7.1 For wagering purposes, the match must be completed for moneyline wagers to be considered action.
- 7.2 A match must be completed within 24 hours of the scheduled start date to be considered action.
- 7.3 For Matchups, all players must start the event for the wager to be considered action.
- 7.4 Retirement or disqualification will deem Sets Betting, correct score, handicap, and total games wagers as no action. If Total Games in a set has been determined Over as the winner before retirement or suspension, that wager will be action.
- 7.5 Retirement or disqualification will deem prop wagers no action except for those already determined.
- 7.6 Future or outright wagers are considered to be action as long as a winner is officially declared, regardless of event relocation, postponement or season length unless otherwise specified.
- 7.7 Future or outright wagers are considered to be action regardless of if player begins play/start the tournament.

8 Golf

- 8.1 A tournament must be completed within 8 days of the scheduled starting date to be considered action.
- 8.2 All events scheduled for 72 holes must complete at least 54 holes to be considered action.
- 8.3 Golfer must tee off for action.
- 8.4 All golfers in a match-up must tee off to start a tournament or the match-up is deemed no action.
- 8.5 If one golfer continues to play after their opponent has missed the cut, withdrawn, or been disqualified, the golfer who continues to play wins the match-up.
- 8.6 If both golfers in a match-up are in a playoff, the winner of the playoff wins the match-up and all other golfers tie each other.
- 8.7 Any reference to make/miss the cut requires an official cut/exclusion by the tournament organizers for bets to stand. In the case where players are eliminated during more than one phase, settlement will be based on the first cut.
- 8.8 Disqualification/withdrawal before the cut will be deemed as missing the cut.

Fubo Sportsbook Iowa House Rules. V.1.4

- 8.9 In match-up bets featuring three or more players, if two or more players tie for first in the group then dead heat rules will be applied.
- 8.10 In top 5 or top 10 wagers, a tie for the 5th or 10th position will be settled by dead heat rules.
- 8.11 For individual round matchups all players in the matchup must start the round otherwise the matchup is deemed no action.

9 Boxing/MMA

- 9.1 All matches must be played on the date and at the location specified. If a match is postponed or rescheduled, wagers will be considered no action unless otherwise specified.
- 9.2 Matches are considered action when the match begins once the bell (buzzer, etc.) sounds.
- 9.3 A full round is defined as one in which the bell sounds to signify the conclusion of said round.
 - 9.3.1 If a fighter is counted out or the match is officially stopped prior to the next bell (buzzer, etc.), the official time of stoppage will be used for wagering.
 - 9.3.2 A half round is defined as the schedule round length divided by two.
 - 9.3.3 If a fight ends exactly halfway through the round, the Over will be considered the winner.
 - 9.3.4 If a fighter fails to answer the bell (buzzer, etc.) at the start of a round, they will be deemed to have lost in that round.
- 9.4 All wagers are considered action regardless of any changes in weight class or championship sanction, unless otherwise specified.
 - 9.4.1 In the event that the length of the match is changed all round related totals and prop bets are deemed no action.
- 9.5 In the event a match is declared 'no contest' or a technical draw in the first four rounds, any market that cannot already be fully settled will be deemed no action.
- 9.6 KO includes knockout, technical knockout, and disqualification. A win by submission in MMA is not considered a KO.
 - 9.6.1 In the event of a Technical Decision before the end of the match, all wagers will be settled as 'win by decision'.
- 9.7 If no winner is declared all wagers will be considered no action unless otherwise specified.
 - 9.7.1 In the event of a draw, wagers on who will win will be deemed as no action.

Fubo Sportsbook Iowa House Rules. V.1.4

- 9.7.2 If a three-way moneyline is offered for win, lose, or draw a draw will be paid out if the official decision is a draw and was selected by the patron.

10 Motorsports

- 10.1 Driver must start the race for action.
- 10.1.1 An abandoned or shortened race will be deemed action if the official result of the race is declared by the organizer
- 10.2 2. In matchups all drivers must start the race, or the wager will be deemed no action.
- 10.2.1 Futures will be deemed action providing the driver starts at least one event irrespective of any consequent team changes, retirements, disqualifications, injuries or for any other reason do not complete the season.
- 10.2.2 Seasonal matchups require both drivers to start at least one event for it to be deemed action irrespective of any team changes, retirements, disqualifications, injuries or for any other reason do not complete the season.
- 10.3 Wagers will be accepted on drivers only in all events apart from Formula One. Constructor Championship wagers are accepted for Formula One.
- 10.3.1 Wagers on Formula Ones Constructor Championship is deemed action irrespective of team member changes, retirements, disqualifications, injuries or for any other reason.
- 10.4 The winner will be determined by the official podium placings published by the respective governing body overseeing the specific event being wagered on.
- 10.5 All races must run within one week of the scheduled start date to be deemed action.
- 10.6 All bets are considered action regardless of change of venue.

11 Australian Rules Football

- 11.1 The entire scheduled period must be completed to have action.
- 11.2 All markets **exclude** overtime unless otherwise stated. Regulation includes any added injury or stoppage time but does not include extra time.
- 11.3 If a match is interrupted and continued within 24 hours after initial kickoff, all open bets will be settled with the final result. Otherwise, all undecided wagers will be deemed no action.
- 11.4 Unless explicitly stated, should a match or a specific period (ex. 1st Half, 4th Quarter, etc.) end in a draw, all bets will be settled according to the dead heat rule.

Fubo Sportsbook Iowa House Rules. V.1.4

- 11.5 All bets made in relationship to player performance, as well as “Head-to-Head” and “Over/Under” bets of one or more players’ performance are considered valid given that the specified players play from the start of the match.
- 11.6 All bets stand, regardless of change of venue.

12 Rugby

- 12.1 All matches must be played on the date specified. If a match is interrupted and continued within 24 hours after initial kickoff, all open bets will be settled with the final result. Otherwise, all undecided wagers will be deemed no action.
- 12.2 All markets are considered for regular time only unless otherwise specified.
- 12.3 Rugby Union markets are based on the result at the end of a scheduled 80 minutes of play plus any added injury or stoppage time unless otherwise specified.
- 12.4 Rugby Sevens markets are based on the result at the end of a scheduled 14 / 20 minutes play unless otherwise specified. This includes any added injury or stoppage time, but does not include extra time, shootout, or sudden death.

13 Table Tennis

- 13.1 Players must start for action. Bets are declared void in the event of a stated player being replaced.
- 13.2 If a match is interrupted or postponed and is not continued within 24 hours after initial start time all undecided wagers will be deemed no action.
- 13.3 Official point deductions will be considered for all undetermined markets. Markets which have already been determined will not take deductions into account.
- 13.4 In the event a table tennis match not taking place or begins and does not finish, bets on the match which have been unconditionally determined are declared not action.
- 13.5 In the event a game is not decided competitively (i.e., a player is given a walkover) bets on this game are declared no action.
- 13.6 Official score sheets are used for the settlement of all bets. In the event that the official score sheet is incorrect, Fubo Sportsbook may use its own recorded statistics for settlement purposes.
- 13.7 Players who are awarded at the podium are declared the event winner for settlement purposes. Any subsequent disqualifications will not overturn the original settlement.

14 Olympics (including trials)

Fubo Sportsbook Iowa House Rules. V.1.4

- 14.1 For wagering purposes, all Olympic winners will be determined by the official IOC Podium results upon a competition's end, and are considered official regardless of protests, reversals, and/or overturned decisions.
- 14.2 For match-up props, all participants involved in the match-up must start or the wager will be deemed no action.
- 14.3 Match-up winners will be decided by the official finish order.
- 14.4 All Olympic wagers will be considered action regardless of date, site/venue, and/or location changes if the event is completed prior to the Closing Ceremonies.
- 14.5 All competitors must start for action. Any disqualification occurring on the field of play will be considered a start and will deem wagers action unless otherwise specified.
- 14.6 Future wagers are considered action even if the selected athlete does not start.
- 14.7 For all Olympic events involving a set length of play, the event must go until at least 5 minutes prior to the predetermined amount of time for action unless otherwise specified.

15 Cycling

- 15.1 Participants must pass the starting line of the respective event/stage for wagers to be considered action.
- 15.2 All wagers are settled on the official listings of the governing body at the time of the podium presentation. Subsequent disqualifications and/or appeals will not affect wagers.
- 15.3 Team classification markets will be settled based upon final standings in time-based classifications.
- 15.4 Matchups will be settled upon the cyclist achieving the highest placing in the specified event/stage.
- 15.5 Matchups will be deemed no action if one or both cyclists fail to pass the starting line.
- 15.6 If both cyclists in a match-up start, but do not finish a stage/event, then the wager will be deemed no action.
- 15.7 If both cyclists in a match-up start, but only one cyclist finishes the stage/event, the finishing cyclist will be deemed the winner.

16 Lacrosse

- 16.1 Wagers are graded after 60 minutes plus any sudden-victory overtime.

Fubo Sportsbook Iowa House Rules. V.1.4

- 16.2 All games must be played on the date and at the location specified. If a game is postponed and/or rescheduled, wagers will be considered no action unless otherwise specified.
- 16.3 Any match abandoned before the completion of 60 minutes play will be void, except for those bets the outcome of which has already been determined at the time of abandonment. The market must be fully determined for bets to stand.

17 In Play Wagers

- 17.1 When wagering on in-play/live markets, if the price has moved against the player request the wager will not be accepted but will instead be reoffered at the new price. A price change in the players favor will be automatically accepted.
- 17.2 Patrons have the option to change their account settings to accept all price changes. If selected, the patron is agreeing to accept all changes made to price, even those not in their favor.
- 17.3 Patrons should be aware that events described as 'live' by broadcasters may be delayed, due to broadcasting or streaming latency. The patron may therefore see odds and line changes relating to on-field activity before the related on-field activity appear on broadcast or the streaming platform. - 18.2 The specific terms and conditions displayed for each bonus, offer or promotion will supersede the general rules in the event that they differ or contradict. By taking part in a bonus, offer or promotion a patron consents to accept these specific terms and conditions.
- 18.3 If any leg of any bonus, offer or promotion that incorporates a combination of legs under a single odds offer is postponed, cancelled or incomplete per respective rules, the entire wager will be cancelled and refunded regardless of the results of the other legs.

- 18.6 For any bonus, offer or promotion Fubo reserves the right to:
- Limit the amount of any qualifying wager. Please note that minimum qualifying wager(s) will be detailed in the specific terms and conditions for that bonus, offer or promotion and all patrons may not qualify for all bonuses, offers or promotions.
 - Limit the potential bonus and/or potential winnings, as provided in the specific terms and conditions for that bonus, offer, or promotion.
 - Exclude any individual or groups of patrons from receiving promotional material and/or participating.
- 18.7 A patron may elect to opt out of receiving promotional material at any time from within their account settings.
- 18.8 Any free bet received cannot be cashed or withdrawn and is subject to the restrictions and/or playthrough requirements provided in the specific terms and conditions for that promotion. Any free bet amount wagered will not be included in any winning returns
- 18.9 No bonus, offer or promotion can be combined with any other bonus, offer or promotion unless expressly permitted by Fubo.
- 18.10 No bonus, offer or promotion will be accepted or honored after the expiration period stipulated in the specific terms and conditions for that bonus, offer or promotion.
- 18.11 In the event that Fubo believes that a patron or group of patrons are abusing or attempting to abuse any bonus, offer or promotion, Fubo may, at its sole discretion, withdraw, withhold or deny benefit for any such bonus, offer or promotion. In addition, Fubo reserves the right to suspend or close the account of any patron or group of patrons it believes to be abusing any bonus, offer or promotion. 19 Parlay/Teaser Rules

- 19.4 The maximum number of legs in a teaser is 10 selections except for the case of 10-point teasers in which the maximum number of legs is 6 selections.
- 19.5 Teasers for professional/college basketball and football are paid according to the charts found below:

21 Deposits and Withdrawals

21.1 Deposits

- 21.1.1 To place Bets or enter certain contests, you must deposit funds in your Fubo Sportsbook deposit account.
- 21.1.2 Funds deposited using a payment provider may take up to a few days to clear before they will appear in the separate, set off account, during which time they will be held in the payment provider’s account.
- 21.1.3 The funds in your Account are held for your benefit to satisfy any payment obligations you may incur as a result of making wagers on the Service, or using any other products or services We supply.
- 21.1.4 Interest is not payable on funds in your account.
- 21.1.5 When you make a deposit, you represent that:
 - 21.1.5.1 All money you deposit originates from a payment source of which you are the legal owner;
 - 21.1.5.2 All money deposited by you is free from and not connected with any illegality, and does not originate from any illegal activity or source; and
 - 21.1.5.3 All payments made into your Account are authorized, and you will not attempt to reverse a payment made into your Account or take any action that will cause that payment to be reversed by a third party to avoid any legitimate liability
- 21.1.6 You may make deposits using several different methods. For information about each payment option, please see [here](#).

21.2 Withdrawals

- 21.2.1 Fubo Sportsbook employs controls and checks before it processes any withdrawal request to protect the security of patron funds.

- 21.2.2 Withdrawals can be requested through any of the methods set forth [here](#).
- 21.2.3 The availability of withdrawn funds is subject to standard banking restrictions.
- 21.2.4 There may be a review of deposits and withdrawals. At Fubo Sportsbook's sole discretion, a patron's account may be suspended or terminated for suspicion or fraud, and any monies contained in an account may be refunded or refused.

21.3 Placing Sports Bets

- 21.3.1 You may only bet up to the amount held within your account, the amount allowed by your bank, or the limit in the House Rule, whichever is the least amount.
- 21.3.2 Fubo Sportsbook reserves the right to accept or decline the whole or part of any proposed bet.
- 21.3.3 Bets placed by debit card will not be valid until we have received payment, or unless we allow the Bet subject to authorization. If we have not received confirmation before an event commences, the bet is automatically void unless we communicate otherwise to you at the time you place the bet.
- 21.3.4 All bets will receive a written confirmation. Once we have confirmed a bet, it cannot be cancelled by the patron. If you have concern regarding whether your Bet has been accepted, you may review all placed and accepted bets in your Account page.
- 21.3.5 When you place a bet, you represent you have exercised your own judgement and have not relied on the advice of any Fubo Sportsbook employee related to any Bet.
- 21.3.6 You agree to pay us for all bets placed using or through your Account.
- 21.3.7 Fubo Sportsbook reserves the right to void any or all Bets made by any group of people acting in conjunction with each other, or any individual acting alone, in an attempt to defraud Fubo Sportsbook.
- 21.3.8 In the event of there being a dispute over the time at which a Bet was placed or whether a Bet has been placed, then the time at which it was recorded (if recorded) on the transactional log will govern settlement. If an attempted Bet was not recorded on the transactional log, no Bet shall be deemed to have been placed. You should check your Account balance each time you visit.

21.4 Your Rights to Set Daily Limits and Exclude Yourself.

You have the right at any time to set time, deposit, or wager limits for your gaming activity or to exclude yourself from placing sports wagers on the Services. Details of how to set limits or to exclude yourself can be found [here](#). Should you choose to exclude yourself, you will be opted out of all bonuses in accordance with the applicable bonus terms & conditions.

21.4.1 Any cashable balance in your Account in the amount of one (1) dollar or more will be mailed to you via a check by the 15th day of the calendar month following the calendar month in which you exclude yourself. Should the cashable balance in your account be less than one (1) dollar at the time you exclude yourself, you will automatically forfeit such balance unless you contact Fubo Sportsbook Support within seventy-two (72) hours of completing your self-exclusion request to request a check for such balance.

21.5 Your Right to Suspend Your Account for a Period of Time Chosen by You.
